

- Concept intended to allow for vertically stacked storage of multiple bins.
- Removable hard top with seal and tie down latches on every bin (not shown in concept). Fork pockets for top removal. The lids must be water-tight. Drainage holes (or other features) for water run-off should be incorporated in the lid design.
- Crane lift-able from/to flatbed truck with full aggregate load (115,000 pounds soil) and sealed lid in place.
- Stress Factor of Safety Yield = 2, FS Ultimate = 3 (appropriate for A-36 carbon steel)
