1. IDENTIFICATION OF AGENCY and/or CONTRACTING ACTIVITY: NASA

2. NATURE/DESCRIPTION OF ACTION: This J&A is for the purchase of brand name items.
3. DESCRIPTION OF SUPPLIES/SERVICES:
  - a. 1EA, Advanced File and Graphics Server (AFGS), Model AFGS-L, Rev. C Firmware, Part No. 7036478-902

  - b. 1EA, Integrated Avionics Computer, Model IC-1080, Part no.7017000-20704

4. IDENTIFICATION OF STATUTORY AUTHORITY: This J&A is based upon the authority of 10 USC 2304(c) (1), as implemented by Federal Acquisition Regulation 6.302-1(c).
5. DEMONSTRATION THAT THE NATURE OF THE ACQUISITION REQUIRES USE OF THE AUTHORITY CITED.
  - a. The items listed above are Plug and Play items that are engineered to specifically operate with an aircraft containing a Honeywell Control Display System and the Pilot's Honeywell DU-1080. The spare items need to have the same specifications as the items they are replacing. If we were to select other parts, the cost of custom wire patch cables, engineering time, fabrication time and time to check out and debug the system would be substantial. Honeywell provides system updates and improvements with the assumption that the system is Honeywell.

FEDERAL BUSINESS OPPORTUNITIES/POTENTIAL SOURCES: The proposed solicitation will be posted on the Federal Business Opportunities website, which is the government wide point of entry. Interested organizations will be permitted to submit their capabilities and qualifications to perform the effort in writing. Such capabilities/qualifications will be evaluated solely for the purpose of determining whether or not to conduct this procurement on a competitive basis.

6. DETERMINATION OF FAIR AND REASONABLE COST: Price fair and reasonable will be determined by performing price analysis.
7. DESCRIPTION OF MARKET RESEARCH: It was determined that Honeywell is the only vendor that can provide these parts. A search of the Internet and catalogs resulted in no other sources that can provide these items.
8. ANY OTHER SUPPORTING FACTS: None.
9. LISTING OF INTERESTED SOURCES: No sources have expressed an interest in this acquisition at the time.
10. STATEMENT OF ACTIONS TO OVERCOME BARRIERS: We are not aware of any actions that can be taken to remove or overcome any barriers to competition.
