The purpose of Amendment 5 is to answer the questions below as submitted by Industry and make associated changes.

1. **Question:** Good morning and hope you enjoyed the weekend. I wanted to check in to see if you might be able to provide any details as it relates to the 2nd pre-proposal conference/bidders site visit that was held late last week. I understand that there was another company that was provided the opportunity to visit and tour the facilities last Thurs/or Friday and was hoping that you could make available the name of the company ? Also, was this 2nd site visit posted anywhere ?

Answer: The names of all companies who participated in the Pre-Proposal Conference and any other Site Visit are and will be posted on the website in the technical library. A site visit was held on Thursday, September 11 with a company that was unable to attend the originally scheduled site visit. Notice of that site visit was not posted anywhere, but the solicitation has been updated to provide any offeror who has not had a site visit the opportunity to request a site visit.

2. **Question:** In reviewing the Amendment 4 documents that were released today, I had a quick question for clarification related to the revised SF1449 (2nd attachment). I have also attached the original RFP SF1449 (1st attachment) that showed the this acquisition as being unrestricted. The revised SF1449 is now also noting “Emerging Small Business” as well is this correct ? If you could please clarify, it would be appreciated.

Answer: The SF1449 was inadvertently marked to reflect “Emerging Small Business.” The SF1449 has been revised to delete “Emerging Small Business.” This acquisition is Unrestricted.
